#### **BACKGROUND AND OBJECTIVES**

The importance of governance for the effective management of protected areas is highlighted by many international guidelines and conventions (e.g. as developed by IUCN and within the CBD PoWPA). Delays in achieving the goals of the PoWPA (e.g. Programme Element 2) are partly due to lack of interest and/or understanding of decision takers and policy makers in understanding and adopting innovative systems of protected area governance, especially in countries with a traditionally centralized system of decision-taking. Improving knowledge on the existing governance types, on their importance, legal and administrative frameworks and resources needed for their use will contribute to adopting appropriate governance types in the Eastern European countries.

Hence, in late 2011 the German Federal Agency for Nature Conservaton commissioned the ProPark Foundation for Protected Areas, Romania to conduct a study on governance of Protected Areas in Eastern Europe. The aim was to document the range of governance models used in Eastern Europe by collecting information from the different target countries in Eastern Europe and thereby promote understanding and recognition for the different protected area governance types by illustration with case studies. This included an analysis of the present situation highlighting some issues, trends, opportunities and concerns as well as outlining the implications deriving from existing policy and practice related to the governance of protected areas in Eastern Europe.

This workshop will analyse and discuss the findings of that study. It will inter alia try

- 1. to promote the project results and to **discuss the findings and conclusions** of the study with the national level representatives;
- 2. to **increase awareness** on the CBD requirements concerning PA governance amongst decision-makers form the Eastern European target countries;
- 3. to **improve the knowledge** of national level representatives on governance by providing them with a theoretical background and with some practical examples from the region;
- to discuss if there is a real need for and possibility to develop a methodology/tool to assess governance and/or a special reporting format on PA governance and demonstrate progress in implementing Goal 2 from the PoWPA;
- 5. to discuss **the need/opportunity for further action** and ways and means how to give incentives to CBD-Parties to engage them in taking more concrete measures in improving and diversifying the governance of protected areas
